Purpose of Special Meeting: To amend the Board's June 18, 2021 decision, granting Amber Oberheim, surviving spouse of Christopher Oberheim, a survivor pension benefit of 100% of salary attached to rank held by the deceased police officer on the "last day of service" pursuant to 3-112(e), in order to reserve the Board's jurisdiction to consider whether or not said survivor pension must be reduced by reason of corresponding survivor benefits received by the surviving spouse pursuant to worker's compensation, as may be required by 40 ILCS 5/3-114.5 of the Police Pension Code.

Please be advised that I represent the Board of Trustees of the Champaign Police Pension Fund. Initially, I express my sincere condolences for the loss of your husband, Christopher Oberheim, on May 19, 2021. He was one of the many men and women who risk their lives every day in order to serve and protect the public. We hold all in the highest regard!

It has come to my attention that on or about June 18, 2021, the Pension Board expedited this matter in order to provide you with a "100% of salary attached to rank" surviving spouse pension benefit, pursuant to 40 ILCS 5/3-112(e) of the Illinois Police Pension Code.

Section 3-114.5 of the Police Pension Code entitled, "Reduction of disability and survivor's benefits for corresponding benefits payable under Workers' Compensation or Workers' Occupational Diseases Acts" requires that pension benefits shall be reduced under the circumstances as provided in said Statute. The "Notice of Hearing" provided to your attention for July 15, 2021 at 1:30 p.m., #10 Henson Place, Suite 2, Champaign, IL 61820, is merely advising you that the Board will, on said date, reserve its jurisdiction to <u>later</u> consider whether or not Section 3-114.5 of the Police Pension Code may apply to reduce any survivor pension benefits. Thus, on July 15, 2021, the Board will not make any determination as to whether or not Section 3-114.5 may apply, or whether any pension benefits shall be reduced accordingly. The intent of the meeting on July 15, 2021, is merely to reserve the Board's jurisdiction to later consider any said action.

Obviously, the Board will provide to your attention timely notice of any further hearing or meeting of the Board respecting this matter. Please also note that you have the right to be

represented by counsel and to present evidence in any proceedings before the Board. In the event you are represented by counsel, I request that you provide to my attention, the name of your counsel and necessary contact information. Once I am advised that you are represented by counsel, any and all further correspondence will be provided to his/her attention.

same injury or disease, the benefits payable under this Article shall be reduced by an amount computed in accordance with subsection (b) of this Section..." 40 ILCS 5/3-114.5.
